SUMMARY PROFILE

Adriana Allen is Professor of Development Planning and Urban Sustainability at the Bartlett Development Planning Unit at University College London, where she leads the research cluster on Environmental Justice, Urbanization and Resilience (EJUR). She is also the Bartlett's Vice-Dean International and is actively engaged in various initiatives promoting trans-local learning and enhanced advocacy and action-research capacity, both within UCL and internationally.

Originally trained as an urban planner in Argentina, she specialized over the years in the fields of housing, public health, urban environmental governance and political ecology. Adriana has over 30 years of international experience in research, postgraduate teaching, advisory and training services undertakings in over 25 countries across the Global South. Through the lens of land, housing, risk, water, sanitation, food and health, her work looks at the interface between everyday city-making practices and planned interventions and their capacity to generate transformative spaces, places and social relations. Her most recent books include:: Untamed Urbanisms (2016), Environmental Justice and Resilience in the Global South (2017) and Urban Water Trajectories (2017) and Handbook of Urban Global Health (2019).

Over the years, she has worked for various international organisations, including UN-Habitat, Department for International Development (DFID/UK), Food and Agriculture Organisation (FAO), UNEP, International Water and Sanitation Centre (IRC), The European Commission (EC) and Directorate General for International Cooperation (DGIC, Belgium), among many others. She is a Visiting Professor at various universities in Latin America, Africa, Asia and Europe and was a beacon for the 2006 IV World Water Forum on institutional development and political processes in water provision. She also acted as a member of Homeless International Advisory Board for many years. Adriana is co-editor of the International Journal of Sustainable Urban Development, and member of the International Advisory Board of Urbanization, among several other international journals.



















ADVOCACY WORK

Her work seeks to carve and deepen opportunities for transformative change, under socially, politically, environmentally and economically challenging conditions. Over the years, she has been an active contributor to various networks working towards the Right to the Habitat, inviting critical scrutiny of emerging buzzwords and contributing to reframing international debates and commitments. Her advocacy work focuses on bringing to the fore the perspective, agency and creativity of those social groups typically marginalised, stigmatised or simply rendered invisible due to their gender, class, age, ethnicity, religion or ability. ACTION-BASED RESEARCH

Adriana attaches fundamental importance to grounding theoretical debates in real-world conditions through transdisciplinary work, seeking to formulate and develop relevant research to confront complex problems and to apply the insights thereby gained to enhance planning processes. Through a series of interdisciplinary action-research projects conducted in partnership with academic and non-academic organisations across many cities in the Global South, her research focuses on deepening the understanding of how and why urban (in)justices are produced, reproduced and transformed. Selected recent and/or ongoing projects include:

KNOWLEDGE IN ACTION FOR URBAN EQUALITY (KNOW). Co-I in an ambitious four-year research programme that bring together a global network of urban researchers and practitioners from 9 countries working together to deliver cities for all. Lead of a WP focused on the role of Urban Planning Education and critical pedagogies to promote urban equality. Funded by the Global Challenges Research Fund (GCRF) Research Councils UK Collective Fund.




